**Essential qualification:** M.Sc. in Polymer Sci. and Technology/ Chemistry/Environmental Science or M. Tech in Chemical Engineering / Materials Science / Biotechnology or any relevant streams with consistently good academic record. Preference will be given to the candidate with NET or GATE qualification.

**Age limit:** Must not be over 28 years as on June 07, 2024 (relaxation is applicable as per the norms/orders of Government of India).

**Desirable qualification:** (i) Prior experiences or hands-on training of polymer processing, (ii) Basic knowledge of textile processing

**PhD opportunity:** The candidate selected for this position may register for regular Ph.D. program in JISIASR, JIS University.
